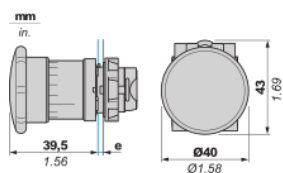

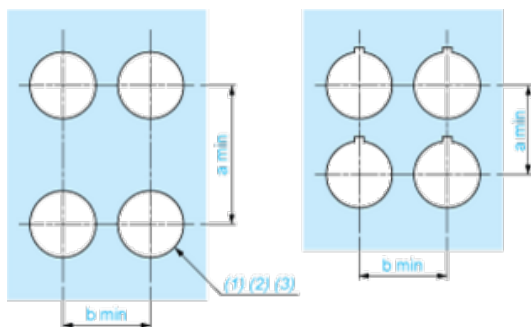

Panel Cut-out for Pushbuttons, Switches and Pilot Lights (Finished Holes, Ready for Installation)

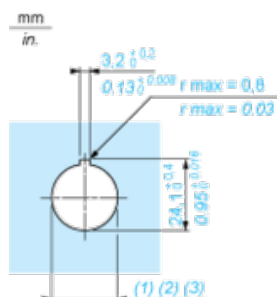
Connection by Screw Clamp Terminals
